- 1. Bidder should be a trade licence from proper authority. Furnish certificate of registration.
- 2. Rate, technical specification, Make and model no., delivery/freight charge, installation fee if any and other shall be mentioned accordingly with related supportive documents.
- 3. Pre-qualification: The tender should be supported with the following documents and original of the same will be verified at the time of opening of quotation.
 - A. GST registration and Income Tax Clearance Certificate for current year.
 - B. Authorized dealership certificate.
 - C. Copy of GST and PAN
 - D. Coloured Product catalogue
 - E. Past supply experience.
- 4. The bidder should have experience of setting up of similar facilities in reputed Universities/College/research institutes. Customer list and evidence need to be submitted.
- 5. The bidder shall bear all expenses of packaging, forwarding, freight, insurance in connection with delivery, repairs and replacements made within the warranty, period.
