1.BACKGROUND

Ambedkar College, a General Degree College under the Department of Education (Higher), Government of Tripura, is situated at Laldahar, a village of scenic beauty in the bank of the river Manu in Fatikroy under Kumarghat subdivision of the Unakoti district of Tripura, Pin:799290. The college was established on 26th September 1991. The college offers undergraduate (UG) programs, i.e. Bachelor of Arts (B. A.) Honours(TDPH) and General (TDPG) in several subjects, viz. Bengali, Education, Economics, English, History, Political Science, Philosophy, Sanskrit, and Bachelor of Science (B. Sc.) both General and hons course in Physical Science with Physics, Chemistry, Mathematics and Zoology and B.sc General Course in Botany, Zoology and Human Physiology.

The Ekalavya Campus of Central Sanskrit University was established on 04-06-2013. At present, Ekalavya campus is running its academic& administrative activities at its own campus site at Lembucherra, Tripura. This Campus strives to translate into reality the vision and mission of Central Sanskrit University. Goals and objectives of the campus are to preserve Sanskrit Language and Indian Knowledge System synthesizing the same with this ever evolving technical world. Ekalavya Campus imparts education in Indian Knowledge System through various courses like Prakshastri(XI & XII), Shastri (B.A.), Shastri Prathistha (B.A. Hons) & Acharya (M.A.). Students are offered Vyakaran, Shahitya, Vedanta, Dharmashastra, Boudha Darshan and Jyotisha as subjects of specialization under these respective departments. Further, students can pursue Shiksha Shastri (B.Ed) here. Research Programmeleading to the degree of Vidyavaridhi (Ph.D) is also offered here. Subjects like Computer Education, Environment Studies, Hindi, English, Bengali, & Political Science are also taughtat Prakshastri & Shastri level as part of the course under the Department of Modern Subjects& Languages.

3. OUTLINE OF COLLABORATION

Under the aegis of this agreement, the parties shall jointly explore the possibilities of working mainly in the North Eastern part of India. The broad areas of cooperation would include the following:-

- b. Taking up studies and action research projects on socioeconomic analysis, livelihood security, market intelligence, value chain and other areas of research in NE region of the
- c. Mutual help in promoting placement of the students of both the institutions in the private
- d. Planning and organizing seminar, conference, workshop, training and capacity building programmes in the domains of entrepreneurship, livelihood promotion, new enterprise creation and cluster development and other common area of specialization of both the institutions. The separate Terms of reference (ToR), deliverables and sharing of the credits including intellectual property rights will be laid down with mutual consensus at the beginning of the activities.

4. PERFORMANCE STANDARD

The parties shall perform their respective roles and responsibilities under this MoU with highest standards of professional and ethical competence and integrity. Both Parties shall also respect rules, regulations and policies of both institutions.

5. VALIDITY OF MoU

This MoU shall have provision of periodic review of the activities and progress. This MoU shall be valid initially for a period of five years, which can be extended by mutual agreement. Any cessation of this MoU by either Party shall be notified in writing to the other Party at least 3(three) months in advance in writing.

6. ARBITRATION

Dispute arising out of this MoU, if any, shall be amicably settled by the parties
